The UK's famous "Non-Dom" regime is no more. After years of working well to attract foreigners to base themselves in the UK, from 6 April 2025, it is abolished and replaced by a much shorter 4-year concession on foreign income and gains for new arrivers. What should UK clients be doing now? What does the investment landscape in the UK look like for these clients? And what about people moving into the UK?
